RESOLUTION AWARDING A CONTRACT FOR FURNISHING AS-NEEDED SURVEILLANCE/ACCESS SYSTEM MAINTENANCE FOR THE COUNTY OF SALEM, BID #26-19 (COMMERCIAL TECHNOLOGY CONTRACTORS, INC. (CTCI) - \$134,112.00)

WHEREAS, the Salem County Purchasing Agent, as authorized contracting Agent for the Salem County Board of Commissioners requested, received and opened sealed bids on July 30, 2026, at 11:00 AM prevailing time for Furnishing As-Needed Surveillance/Access System Maintenance for the County of Salem, Bid #26-19. The receipt of said bids was duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, bids were received as follows:

Advantage Security Inc.	Wilmington, DE	\$136,288.00
Commercial Technology Contractors, Inc.	Clifton, NJ	\$134,112.00

WHEREAS, all bid results are on file in the office of the Purchasing Agent, 110 Fifth Street, Suite 400 in the County of Salem New Jersey as required by law; and

WHEREAS, the Salem County Administration has reviewed the documents and recommend approval to Commercial Technology Contractors, Inc. for this award; and

WHEREAS, no amount will be encumbered until such time as goods or services are ordered; and

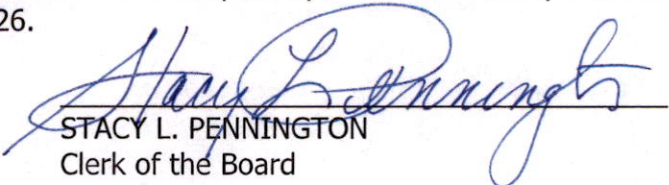
WHEREAS, the Purchasing Agent and/or CFO/Treasurer, upon approving the release of a purchase order, shall ascertain that there are available sufficient uncommitted appropriations to provide payment.

NOW THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. The Salem County Board of County Commissioners hereby awards a contract for Furnishing As-Needed Surveillance/Access System Maintenance for the County of Salem to Commercial Technology Contractors, Inc. the cost of which shall not exceed \$134,112.00, the term shall commence upon award by the governing body and terminate on July 31, 2027, with two (2) additional one (1) year extensions.

2. The Commissioner Director and Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.
