**RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR PROVIDING
VARIOUS SOCIAL SERVICES FOR THE HOMELESS FOR THE SALEM COUNTY
DEPARTMENT OF SOCIAL SERVICES, RFP #26-21 (CATHOLIC CHARITIES
SOUTH JERSEY - \$27,268.50)**

WHEREAS, the Salem County Purchasing Agent, as authorized contracting Agent for the Salem County Board of County Commissioners requested, received and opened sealed proposals on Friday, August 21, 2026 at 11:00 AM prevailing time for Providing Various Social Services for the Homeless for the Salem County Department of Social Services, the receipt of which was duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all proposal results and recommendations for contract award are on file in the office of the Purchasing Agent, 110 Fifth Street, Suite 400, in the County of Salem, New Jersey; and

WHEREAS, vendors who submitted proposals for Providing Various Social Services for the Homeless for the Salem County Department of Social Services are as follows:

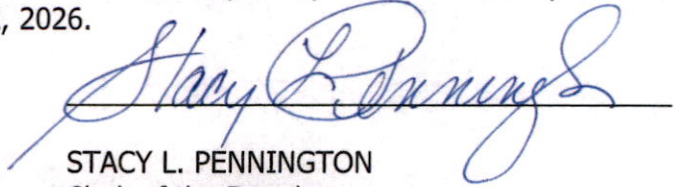

WHEAREAS, it has been determined that Catholic Charities South Jersey is qualified to provide the aforesaid services of the type and nature required.

NOW THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that:

1. That a contract is hereby awarded to Catholic Charities South Jersey, 1845 Haddon Avenue, Camden, NJ 08103 in the amount not to exceed \$27,268.50.
2. The contract shall commence upon award and terminate June 30, 2027, the County shall have the sole option to extend this agreement for two (2) additional one (1) year extensions.
3. That the Director and Clerk of the board be and the same are hereby authorized and directed to execute the contract hereby awarded.

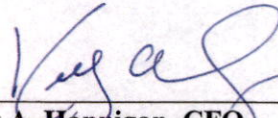
